Description of Cookie	Purpose
Google Analytics (_ga)	This cookie is associated with Google Universal Analytics and is used to distinguish unique users. It is included in each page request in a site and used to calculate visitor, session and campaign data for the site's analytics reports.
Google Analytics (_gid)	This cookie stores and updates a unique value for each page visited.
Google Analytics (_gat)	Default Google Analytics cookie used to limit the collection of data on high traffic sites.
